

**COOKIES POLICY**

#### 1. Introduction

This cookie policy explains what cookies are, and how NASD Plc. (hereinafter referred to as "we", "us" or "our") uses cookies through our website located at <a href="https://nasdng.com/">https://nasdng.com/</a>, and your choices regarding cookies on our website. By using our website, you agree to the use of cookies as described in this policy.

# 2. What are Cookies?

Cookies are small text files that are stored on your device (computer, tablet, or mobile phone) by a web browser when you visit a website. They are widely used to ensure websites work efficiently as well as to provide information to website owners.

In other words, Cookies are a kind of short-term memory for the web, stored in your browser and enable a site to 'remember' little bits of information between pages or visits. They can be used by web servers to identify and track users as they navigate different pages on a website, and to identify users returning to a website.

Cookies may be either "persistent" cookies or "session" cookies. A persistent cookie consists of a text file sent by a web server to a web browser, which will be stored by the browser and will remain valid until its set expiry date (unless deleted by the user before the expiry date). A session cookie, on the other hand, will expire at the end of the user session, when the web browser is closed.

# 3. Types of Cookies on our Website

### Several types of cookies may be used on our website including but not limited to the following:

We use both SESSION COOKIES (which expire once you close your web browser) and PERSISTENT COOKIES (which stay on your device until you delete them).

We have also grouped our cookies into the following categories, to make it easier for you to understand why we need them:

- (a) **Functionality Cookies**: these cookies enable the technical performance of our websites and allow us to 'remember' the choices you make and your preferences. These Cookies may be used to provide you with a more personalized experience.
- (b) **Performance Cookies**: these cookies allow us to collect certain information about how you navigate the Sites. They help us to understand which parts of our websites are interesting to you and which are not, as well as what we can do to improve them.
- (c) Essential Cookies: These cookies are necessary for the proper functioning of our website and enable you to navigate our site and use its features. Without these cookies, certain services may not be provided.

(d) Analytics Cookies: These cookies allow us to analyze how visitors use our website, which helps us improve the user experience. We use tools like Google Analytics to collect information about website traffic and usage patterns.

### 4. How We Use Cookies

Cookies do not contain any information that personally identifies you, but personal information that we store about you may be linked, by us, to the information stored in and obtained from cookies. The cookies used on this website include those that are strictly necessary cookies for access and navigation, cookies that track usage (performance cookies) and remember your choices (functionality cookies). We may use the information we obtain from your use of our cookies for the following purposes:

- To recognize your computer when you visit our website,
- To retain clients' email addresses and passwords when they log in to our website.
- To track you as you navigate our website
- To improve the website's usability i.e. our Live Chat application to answer questions you have in real time,
- To analyze the use of our website such as how many people visit us each day
- In the administration of our website
